Basic Services

Caring Hearts Child Development Center provides a social and age appropriate program for children from two months to six years old. Two, three and five day classes meet Monday through Friday. In addition, day care is available between 7:00 am to 6:00 pm. The tuition rates are attached.

Refunds

A two week written notice is required for termination of this agreement. All unused tuition will be refunded if a two week notice is given. The initial registration fee and half of the first months tuition deposit is not refundable.

Rights of Licensing Agency

The State of California General Licensing Requirements, Section 101195 states:

The Dept. of Licensing Agency shall have the authority to interview children or staff and to inspect and audit child or facility records without prior consent.

The Licensee shall make provisions for private interview with any child(ren) or any staff member and for the examination of all records relating to the operation of the facility.

The Department of Licensing agency shall have authority to observe the physical condition of the child(ren) including conditions which indicate abuse, neglect or inappropriate placement and to have a licensed medical professional examine the child(ren).

Termination of Agreement

This agreement is terminated when a child leaves the program and all of the tuition due has been paid. Parents or Caring Hearts may terminate this agreement after giving a two week written notice.

RELEASE

Caring Hearts Child Development Center (the school) and staff make every effort to maintain a minimum of child injuries by closely supervising the children to ensure that they conduct themselves in a safe and proper manner. However, where there are active children participating in a program which includes inside and outside play on play equipment, physical education there is always a chance for injuries. Most of the injuries that occur are the nature of bumps, abrasions, sprains, etc.

I, the undersigned, by enrolling my child(ren) in a school program, assume all the risks which are inherent in such a program and hereby authorize the school's personnel to obtain emergency medical assistance for my child(ren) listed below and to transport the child(ren) to the same, both at my expense. The undersigned further acknowledges that the school is not an insurer against injury and that the school offers its services at a cost which reflects the fact that the school will not and cannot be momentarily responsible for personal injuries which might occur to the child(ren) while on the premises of the school. The undersigned agrees to hold the school and its staff harmless for liability for damages arising out of injuries sustained by the child(ren) as a result of the school's owners, directors, employees and agents or any other individuals for whose acts the school might otherwise be liable except through gross negligence or willful misconduct on the parts of such individuals. The undersigned agrees to hold the school and authorized personnel harmless from liability for damages arising out of personal injuries sustained by child(ren) as a result of the defective quality or performance, either as to manufacturing or design, of any equipment or facilities used by the school in its business when the defective nature and/or danger-propensity of such equipment is unknown. The undersigned further grants the school or its designated employees the right to administer reasonable and appropriate discipline (not involving corporal punishment) as the need for such discipline occurs. The undersigned understands that it is important to the school that the parents and child(ren) maintain good relationships with the staff/administrators. The school reserves the right to decline continued enrollment to parents who in the school's judgement are uncooperative or abusive to school staff/administrators. The undersigned agrees that if there is a legal or other claim against the school or any of its staff/administrators, which has not been resolved through negotiation with the school, the undersigned is required to submit the claim for binding arbitration in accordance with the arbitration rules of the American Arbitration Association. The undersigned grants the school the right to use the reproduction, electronic or magnetic recording, photographs, etc. of the enrolled child(ren) for educational advertisement or entertainment presentations for parent or teacher training and for general public information. The undersigned agrees that such use by the school be without any obligation to pay any money to anyone.
